Juror

Barbara Shaiman has been the Director (artistic and managing) of the Seattle Art Museum's SAM Gallery, Art Sales and Rental, for the past 18 years, during which time the gallery has more than quadrupled in size. In addition, she is the Curator of the Alexis Hotel. Barbara also devotes time to jurying community art exhibits, participating in public art panels, advising local arts organizations and doing independent art consultation. Before joining the SAM staff, Barbara taught art in NYC at Brooklyn College and Brooklyn Museum Art School, at Hawthorne Studio in Montana, and locally at Seward Park Arts Center and Bellevue Community College. She was also a working ceramic artist and the owner/director of Shaiman Gallery, a local contemporary fine crafts and design gallery.

"My curatorial approach is affected by my background as a working studio artist and instructor of studio courses. For me the visual is primary, and then comes attention to concept and execution. When I choose artists for an exhibit or jury a show, I look for artwork that has strong visual appeal and is rooted in ideas I find compelling, stimulating and challenging."

Eligibility

- Artist must be 16 years of age or older and resident of WA, OR, ID MT, AK or British Columbia.
- Entries must be original, entirely the work of the entrant, executed within the last three years, and without the supervision of an instructor.
- Entries must not be copied, derivatives, or based on other copyrighted or published paintings or photographs.

Conditions

- Entries will be juried from slides or photographs/printed images (no e-mailed images). Awards will be judged from the original works of art.
- Work in two-and three-dimensional form including photography is eligible. Sculpture may not exceed 60" x 24" x 24" Two dimensional work may not exceed 60" height x 44" width including frame.
- Unless artist installs, no work may exceed 50 pounds in weight.
- All two-dimensional works on paper must have glass or plexiglass. Work must be sturdily framed and ready to hang, including wire. Shipped paintings must use plexiglass. Hand delivered work may use glass.
- Artists may not substitute another work for an accepted work, alter the work or the sales price, nor withdraw the work after it has been accepted.
- Art Port Townsend reserves the right to refuse any work which does not match the slide or meet the media, size or framing criteria.

Entries

- We accept either 35mm slides or printed images (4" x 6" to 5" x 8") on or mounted on 8 1/2" x 11" photo quality paper. Slides must be 35 mm, in a standard 2" x 2" mount. No glass slides or unusually thick mounts will be accepted. No tape or attached labels should be used.
- A maximum of three entries per artist may be submitted for jurying.
- For sculpture, up to three slides or images may be submitted per entry.

Entry Fees

A non-refundable entry fee of \$25 is required for a maximum of three entries, payable to Northwind Arts Alliance. Entry postmark deadline for slides/printed

images, entry form and fees is Monday, August 11, 2008.

Accepted Works

- Works can be hand delivered or shipped. Instructions will be mailed in the notification letter. There will be a \$10.00 charge for each shipping container.
- If your work is not accepted, images will be returned in your SASE envelope. Although the utmost care will be taken in handling slides and artwork, the Port Townsend Arts Commission, Northwind Arts Alliance, Northwind Arts Center or its representatives will not be responsible for damage or loss from any cause. If accepted, images will be retained for records.

Sales

Unless specified NFS, it is assumed that all work is for sale. Northwind Arts Center will charge a 30% donation for each art work sold.

Photography

Art Port Townsend reserves the right to photograph entries for the purposes of documentation, education, publicity, and to encourage interaction of the arts.

Liability

Every reasonable precaution will be taken during the receiving, installation, exhibition, and return of work, but neither Port Townsend Arts Commission nor Northwind Arts Alliance will assume responsibility for loss or damage incurred. Artists should carry their own insurance. Work should not be so fragile that shipment or public display is potentially harmful to the work or the viewer.
