Juror

Gary Faigin has been a full-time art professional for over 30 years, with notable accomplishments as a painter, educator, and art critic. Faigin has been an exhibiting artist since 1985, most recently at the Woodside/Braseth Gallery in Seattle (1995-2007), and the Linda Hodges Gallery (2010). Faigin’s work has been featured in ten solo exhibitions, including two museum shows: Frye Art Museum (2001 w/catalog) and Coos Art Museum (2008). Faigin’s artwork has also been highlighted in several dozen newspaper and magazine articles, and was on the cover of *American Artist* (1996). After ten years of teaching in New York, Faigin moved to Seattle in 1991. In 1989, he co-founded, with architect Pamela Belyea, the Gage Academy of Art, a school emphasizing a “back to basics” approach to art education, focused on painting, drawing, and sculpture. Faigin’s 1991 book, *The Artist’s Complete Guide to Facial Expression*, is a recognized classic in its field, now in its 18th printing and translated into six languages. It is the standard reference on the subject for digital animators, forensic artists, and portrait painters. Faigin has been the Art Critic for NPR station KUOW since 2000, having broadcast almost 100 reviews of museum and gallery exhibitions. His reviews are also published monthly at the arts website www.artdish.com

Eligibility

- Artist must be 16 years of age or older and resident of WA, OR, ID MT, AK or British Columbia.
- Entries must be original, entirely the work of the entrant, executed within the last three years, and without the supervision of an instructor.
- Entries must not be copied, derivatives, or based on other copyrighted or published paintings or photographs.

Conditions

- Work in two and three dimensions including photography is eligible. Sculpture may not exceed 60" x 24" x 24". Two dimensional work may not exceed 70" height x 44" width including frame.
- Unless artist installs, no work may exceed 50 pounds in weight.
- All two-dimensional works on paper must have glass or plexiglass. Work must be sturdily framed and ready to hang, including wire. Shipped paintings must use plexiglass. Hand delivered work may use glass.
- Artists may not substitute another work for an accepted work, alter the work or the sales price, nor withdraw the work after it has been accepted.
- Art Port Townsend reserves the right to refuse any work which does not match the entry or meet the media, size or framing criteria.

Entries

- All entries will be juried from digital images. Awards will be judged from the original works of art. Mail your entry form and include a CD-ROM with your images or mail your entry form and attach your images to an email to:

images@artporttownsend.org

- Please do not embed your images in the text of the e-mail message. Send high quality jpeg images, at least 1024 pixels along the longer dimension. Image files cannot exceed 2MB. File name must be in the following format: lastnamefirstinitial_title.jpg (Mac users be sure to add .jpg extension.)

- Please check our web site at: www.artporttownsend.org for additional guidance on submitting images, and how to avoid common problems and rejection.
- A maximum of three entries per artist may be submitted for jurying.
 - For sculpture, up to three images may be submitted per entry.

Entry Fees

A non-refundable entry fee of \$45 is required for a maximum of three entries, payable to Northwind Arts Alliance. Entry postmark deadline for images, entry form and fees is Wednesday, June 1, 2011.

Accepted Works

- Works can be hand delivered or shipped. Instructions will be mailed in the notification letter. There will be a \$10.00 charge for each shipping container.
- If your work is not accepted, CDs will be returned if you send a SASE envelope. Although the utmost care will be taken in handling entries and artwork, the Port Townsend Arts Commission, Northwind Arts Alliance, Northwind Arts Center or its representatives will not be responsible for damage or loss from any cause. If accepted, images will be retained for records.

Sales

Should your work(s) sell, Northwind Arts Alliance will pay you a wholesale price equal to 70% of the retail selling price. Northwind will pay Washington State sales tax.

Photography

Art Port Townsend reserves the right to use images and to photograph entries for the purposes of documentation, education, publicity, and to encourage interaction of the arts.

Liability

Every reasonable precaution will be taken during the receiving, installation, exhibition, and return of work, but neither Port Townsend Arts Commission nor Northwind Arts Alliance will assume responsibility for loss or damage incurred. Artists should carry their own insurance. Work should not be so fragile that shipment or public display is potentially harmful to the work or the viewer.
